Be sure to check out the compiled timeline in the accompanying Excel file that displays all of the event, jobs, etc. Frank lays claim to that I have addressed in this document. Compare how many things he claims to have been doing simultaneously and consider how implausible (even impossible, in some cases) some of them were. Several entries actually contradict each other.

For example, look at how many things Frank claims to have been doing while serving as a Nave SEAL (or “Seal,” as he calls them)--apparently, while serving in this elite Naval unit that is so busy that its members are rarely ever home to spend time with their families, Frank was also a firefighter, police officer, earning his Masters degree, his Doctorate, was on the Olympic Weightlifting team, was in a movie (“The Omega Code”), had multiple editing and writing jobs with various publishers, and was a vice-principal (amongst other things.)

I leave it up to you to decide what you want to believe while viewing everything in such a handy graphic.

Note that the **black bars** are periods when inadequate information makes the timeline wholly or partially to place the activity.

Note that because of how time intensive this research was, I've put no time into editing, so please forgive any spelling errors or the like that would not normally escape me were I actually getting paid to do this.

IMPORTANT: Author's Means of Verification

Because the subject of this research, Frank Victor Beckles, has a habit of assuming the names of people he believes have acted against him in order to discredit them and create the illusion that they are apologizing to him or professing their guilt with regards to what Frank considers inappropriate behavior, I am taking steps as proof against this. Any post I make to address anything related to Frank Beckles outside of communications means I control entirely will include a randomly generated code. This code will also appear on the Misfit Studios web forum at <http://misfit-studios.com/board/viewtopic.php?f=1&t=4909>, accompanied by a link back to the post when possible. This also goes for any seemingly unrelated strange "confessions" or comments, related to Frank or not, that may pop up afterward. If it doesn't have such a code, it is not me speaking, but rather someone using my name without my wishes.

Who Is Steven Trustrum and Why Does He Care About Frank Beckles?

My name is Steven Trustrum, and I have been a professional freelance writer in the role-playing game (RPG) industry since 1999, and own a small press publishing company.

Anyone who knows me will tell you that I hate bullies. Because it has happened to me a number of times, I also despise people who stomp all over the hard work other people do by trying to claim ownership of it.

If you look at my G+ page at <https://plus.google.com/109865496605435147776/posts>, you will see a few instances of me providing proof of someone else taking credit for someone else's work and selling it professionally as their own. Most notably, I and several others put no small amount of effort tracking down images and content a wannabe RPG publisher, "Mykal Lakim" of Dark Phoenix Publishing had taken from photographs and other games, not to mention claiming other game companies had stolen his ideas and work years before, excusing why their content appeared in his recently released product.

But how does this lead to me looking into the man most often referred to as Frank Beckles?

In late August of 2013, someone over at ComplaintsBoard.com contacted me. I'd had previous dealings with her due to my day job and some posts I'd made on the forum because of it, so it seems she looked into me as a result. She noticed I wrote parts of the latest DC comics RPG for Green Ronin, under license from DC and, having also seen my G+ account, she knew I hated people who claimed credit for other people's work.

She emailed some links to a few of Frank's ComplaintsBoard threads and external websites. After sifting through Frank's long-winded, rambling writ-

ings that spit in the face of paragraphs, punctuation, good grammar, and proper spelling, I saw why this person had contacted me specifically. Frank was claiming he had done work on a great deal of comic book projects, including those involving DC's intellectual properties.

Comic books, trading cards, movies, TV shows, professional and amateur athletics at the top levels, military special operations, fire fighter, cop, and "9/11 hero" are just a few of the things this guy laid claim to.

That was all it took. I was hooked. This guy was obviously a liar at worst or an extreme exaggerator at best, and I knew I could prove it with some effort and time. Even if I ran into some dead ends, the guy simply tossed so much BS up against the wall to see what would stick that even debunking a small fraction of it would show his claims were not to be trusted.

Making matters worse was the fact that Frank Beckles was on a campaign to slander and vilify anyone who poked holes in his fantasies, going to the point of making up stories about them and using fake accounts online in their name (and those of others who apparently know the targets of Frank's ire) in order to declare "confessions" from these people, saying how evil they are and how they did Frank wrong.

The guy is a bully.

What follows is the report I've prepared on Frank's online presence and real life, and what I was able to uncover about the type of guy he is and how he seeks to portray himself.

Sometimes, looking into one of Frank's claims required simply poking around online to find the

truth of the matter, be it hard evidence and facts or merely strong supporting—if circumstantial—inferences rather than proof. At other times, I spent quite a while on the phone, on hold or being bounced from one person and number to the next, or had to file applications and wait for the results via email or the mail. Some of this actually took a bit of work and perseverance, but it doesn't necessarily mean the same for you if you want to double check my sources thanks to the groundwork I've already done.

When possible, I have backed up everything I say regarding Frank with links to relevant source material, phone numbers, or emails that are related to a given claim. You can call up any phone number I used during this process, or email the same people I did—I used information that is available to the public in my efforts to verify Frank's claims, so if I could find it in the first place, you can now use it, too. Don't just take my word regarding what I found: check for yourself using the same sources I did, or do some digging and find your own evidence (perhaps something I missed), and visit Frank's many websites to see if you come to the same conclusions about the man as I did.

I also provide some personal commentary on the opinion I form of Frank based solely on the information and content he has chosen to throw out there into the Internet, so if he ends up seeing this and thinks he is being slandered or treated unfairly, I'll provide the links and explanations detailing how any such response to him is his own fault.

Now that you know who I am (and that I'm a bit long winded), and why I went through all this effort, have a look at what I found out.

After that, she supposedly went and married Frank's fictional Matt Gagston, with whom she now has a son, Christian. Copyscape reveals the article is 66% ripped off from <http://www.horrorchronicles.com/babes-of-blood/babes-of-blood-neve-campbell.html>. Frank interjected his own name and supposed relationship into the article he plagiarized.

Repeats claim he was Neve Campbell's lover, among other things.

Carla "CMG" Green, Former Wife and Lover PLUS Brandy "Special One" Floyd, Former Wife and Lover

Frank claims the pair are the "Former Wife & Lovers of Famed TV Show Star; Dr. Frank Victor "The Iceman" Beckles, Jr.)" He adds "Carla Green is also a renown Civil Rights Leader, that often helps other heroes; like former lover, & Best Friend- Dr. Frank Beckles, Jr.!!!"

As I cannot find any corroborating bio information regarding Brandy Floyd or Carla Green either way, there is no absolute proof these claims are fiction or true, he has elsewhere said that his son, Christian, has the last name "Green" (although he elsewhere says the surname is also Beckles.)

Encounters with the Law

Check out Frank’s criminal record for yourself. you’ll see two cases against Beckles, Franklin V and one against Beckles Jr, Franklin V. Although it is not abnormal to have traffic violations, keep it in mind as a part of the big picture when you start learning more about the man.

One was an **improper use of a center turn lane (Oct 3, 2009; \$280 fine)**, another was **failure to wear safety belt and no brake lights ticket (Aug 8, 2010; \$155 combined fine)**, but it’s the third that was noteworthy.

Frank was charged with **obstruction and hindrance of a law enforcement officer** on **Feb 14, 2011**, and was arrested for that charge on the same date. It seems he demanded a jury, and filed an indigent defense application (getting the state to supply a defense lawyer due to insufficient funds.)

Frank’s lawyer was allowed to leave the case; it has been explained to me by a lawyer that the progress of events may be that he refused to pay his lawyer fees (based on the IDAF payment orders), so the defense lawyer asked off the case and Frank was ordered by the court to pay, but that is just his interpretation of the limited information, not a proven fact.

Frank entered a plea of **nolo contendere (no contest)**, and was sentenced to time served. Of note is the major gap between the counsel being allowed to withdraw in 2011 and his bond forfeiture hearing in 2013, leading into the final court days before the plea.

Misogyny / Anti-Feminism

The following speaks to the value Frank places on women, including how he talks about his wife, his views on feminism (and what he considers feminism in the first place), and how he ties those to his religion. As you look over these sites, don’t forget how vehemently Frank portrays himself as a Man of God, including teaching children in his Christian Learning Center and as a licensed minister.

Also, see the section on Alexander Pope / Matt Gagston. These two identities seem to have been, in part, to allow Frank to express how he really feels about women: he pairs them with porn actresses (e.g., <http://thebabymakers2012.blogspot.ca/>), seems to take pride in them being adulterers, and essentially reduces the women he puts into their lives to becoming a “babymaker” (his words: <http://www.flickr.com/groups/chroniclesofgagstonandpope/rules/>; note that this page also has links to porn sites in it)

On top of these specific instances, reading through the Tracey McManus drama at ComplaintsBoard makes it clear Frank does not like a woman getting the better of him.

It is worth noting he refers to himself as “The Mac Daddy” on this page, and the background includes some images I would not expect of a reverend/pastor/bishop. It is like a stalker collage of scantily clad women.

Some of the pictures have clearly been scanned instead of having been grabbed online, and have slogans like “bitchbastard,” “bitchbastard women are bastards,” and “Taria – the mother of my sons” hand written upon them in black marker prior to being scanned.

Claims “The Bastard Woman” (one of Frank’s favorite misogynistic terms) is also being made into a movie for a 2011 release. On the LinkedIn site, he mentions this movie and “The Babymaker.”

States the page is for anti-feminists only; claims to write paper with Cathy Young in 2007 that appears here: <http://reason.com/archives/2007/01/09/the-evolution-of-an-antifemini>, but the original makes no mention of Frank. The page also includes misquotes of the Bible re: 1st Samuel 15:23:

-“Feminism is Evil.”-1st Samuel 15:23

Here is a website providing the various translations this passage has appeared as in different versions of the Bible. You’ll note none of them translate it as “Feminism is Evil.” <http://www.biblegateway.com/verse/en/1%20Samuel%2015:23>

Frank answers someone’s question about being worried that their older boyfriend may be cheating on her because he doesn’t ejaculate during sex. Scroll down until you find his answer:

“Sounds like you need a new bf... I’m in my late 30’s, and I don’t have that problem! I’m with a female whose not attractive, maybe we should switch partners.”

This is Frank talking about the mother of his children. Also keep in mind he constantly refers to himself as a man of God (pastor/bishop/reverend) as you read this. Now, Frank may try to wiggle out of this by claiming it is an account created by one of the many people he says are trying to discredit him, but keep in mind a) the account and this particular post were made 2 years ago, and then there are the two questions posed below that would not make sense for someone to make if they were looking to give Frank a bad name.

Civil Rights

Frank makes **many** claims about being an “**unsung hero**” of the Civil Rights movemnet. He even claims he’s been given some awards because of it. I’ve only posted some of the sites he makes such claims, but read just about anything he posts and you’ll come across these claims. Over and over.

Merely Google “Dr Charles J Smith SR NAACP” and you’ll find **LOTS** of legitimate news articles and official NAACP releases with his name on it.

Religion

Go to just about any of Frank's many sites and you'll see him referring to himself as a Pastor, Reverend, Minister, or Bishop interchangeably. Sometimes he even combines them. So, keep in mind the image Frank is constructing of himself as a Man of God and minister as you read through his websites and review his behaviour.

The only information I can find on this ministry is that which Frank himself provides on his many websites. The list of churches in Georgia makes no mention of it.

The address provided is a private home. A quick, public search on 411.com lists **Adrian Beckles** (Frank's wife) and **Beatrice Darren** as the residents. http://www.flickr.com/people/augusta_christian_center/ lists Beatrice as one of the church's founders, and "**Beatrice Darren**" is also a name used on ComplaintsBoard.com to post in many of Frank's complaint threads while using the same posting style and grammar as him, making it highly likely he is using her name as one of his online identities.

Note that Frank solicits donations for his church.

I found a scan of his ordained minister's license from the American Fellowship Church at <https://gagstonand-pope.shutterstock.com/64#62> (although I don't know if it's been renewed since it expired in April of 2010.) It's worth noting that, as their site indicates <http://www.amfellow.org/>, just about anyone can become a licensed minister from them online.

Essentially, you have to read their terms of service and pay their fee (it costs more to get a certificate and license, for example, and prices go up the longer you want the license to last for.)

His son, Christian Alexander Beckles, is also a minister according to Frank

The problem with this is there is **no** Black Wolves Battalion in the Army National Guard. In some places he says he served in "the" Gulf War, and in others "both" Gulf Wars. Here are the dates of those two wars. Compare them to Frank's years of military service and all the other things he claims to have been doing during these times. Decide for yourself if you believe Frank partook of either or both Gulf Wars

First Gulf War: August 1990 to February 1991

Second Gulf War: March 2003 to December 2011

* This is how Frank spells "SEAL". I happen to know "Seal" is actually "SEAL" because it is an acronym for "SEa, Air, Land", but Frank does not seem to know this (or doesn't care, which would be odd for a real SEAL, who would view the "Seal" spelling as an insult.)

On this page, Frank does not mention being a SEAL but claims he was discharged under a **RE-4 Code**, meaning his military record had an official recommendation not to allow him to re-enlist after being discharged, and that he was demoted by a "**Captain's Mass (court)**" (sic) (this is actually a **Captain's Mast**) for assaulting another sailor.

As best I can determine (it is difficult to be certain because of the lack of paragraphs, punctuation, or anything resembling competent grammar or proper spelling), he joined the Navy without knowing how to swim (so he entered SEAL training without knowing how to swim? Even if he learned how to swim after signing up, it does not seem likely he reached the level of competency required to become a SEAL in that short a time.)

Also note that the story outlined here provides no time or opportunity to become a SEAL, and entirely fails to mention anything related to the SEALs, which is extremely odd, as it would seem to be incredibly relevant to mention his treatment during such training and assignment considering the context of his story.

The gist also seems to be that his time in the Navy ended in **1994**.

The civilian employee at the **Naval Special Warfare Command** I spoke to, **Eric S. Erdmann, FOIA Coordinator / Privacy Act –POC**, also verified what Don Shipley told me: fake SEALs often try to cover up their lack of BUD/S or SEALs training records by claiming they are classified. Mr. Erdmann assured me that, no matter what someone is assigned to afterward, the BUD/S and SEAL training records are never expunged—they always remain, no matter what.

Sept. 9 2013/Sept. 16 2013: I filed a Freedom of Information (FOI) request on the 9th and received it on the 16th from the Department of the Navy, Naval Special Warfare Command. The results, as scanned and presented on **pages 74 &75**, provide **official** government proof that Frank was **never** a member of the SEALs (not even as a flunked trainee.)

My request was assigned file number **13-145N**. Soon after, I received a separate email from **R.D. Russell, Co-Director of Naval Special Warfare Archives**, simply stating:

"There has never been a Navy SEAL with that name."

September 4 2013: I contacted **Senior Chief Don Shipley**, a man who is famous for using the SEAL database to expose people falsely claiming to be Navy SEALs (if you don't know who he is, I suggest you look him up, especially his Youtube channel.) This guy is the real deal, and can easily go online and check a secure database to see if someone has attended (whether they pass or fail) BUD/S or SEAL training. He informed me he did not find anyone with that name, or any alternate spellings or similar pronunciations, having attended or passed either BUD/S or SEAL training, looking as far back as 1943. Chief Shipley even points out that undergoing a legal name change would have left a trail. In Chief Shipley's own words:

"I can state conclusively that Franklyn Beckles never completed SEAL training, and he is not now, nor was he ever a Navy SEAL or a Navy Underwater Demolition Team Member."

Don Shipley states that many people who are busted as fake SEALs will say their records are not included in the database because they are classified. To this, Don Shipley (and every other SEAL/Navy source I checked) stated that even SEALs who later become in classified operations are never removed from the database, and their records of attending BUD/S and SEAL training remain entirely intact. And, of course, there is the simple fact that if someone had been involved with something so classified that their attendance in BUD/S and SEALs training was "erased," **there would be no way they'd be plastering it all over the Internet.**

I'm not saying Frank has (yet?) said this as a reason for no record of him as a SEAL, but keep this in mind in case that is how he responds to this false claim being uncovered.

Admits he was a **Seaman Recruit (E-1)**, the lowest possible rank in the Navy, at <http://www.angelfire.com/sc2/frankbecklesjr>, which is six ranks lower than the rank of **Chief Petty Officer (E-7)** he claims here.

Even if we take him at his word that he once obtained the ranks of E-7 prior to the Captain's Mast ruling he admits to on this angelfire site, the sort of infraction he would be found guilty of that would bust him down **6 ranks** is extremely rare (especially without anything more severe tacked on, like some extended time in confinement.) It certainly wouldn't occur for simply "shoving" another sailor.

As with many of Frank's rants, this account seems to have been constructed to attack lawyers involved in disability cases or makes claims of racist behaviour. A quick search of the Georgia Bar reveals <http://www.gabar.org/membership/membersearch.cfm> there is no lawyer with the surname "Beckles" licensed to practice in the state. It's also worth noting I've yet to find attending law school amongst any of Frank's claims, on his many LinkedIn pages or otherwise.

Sept. 18, 2013: I have confirmed Frank has never been a fire fighter with Williston and has not been its fire chief at any point. (See [page 84](#) for an image of the email.)

I received a response to an email I sent to Williston's public email regarding Frank's claim to having been a fire fighter and fire chief with them. The response I received bounced between **Chief Milton Widener** of the Williston Fire Dept. and **Angela Overton**, the town's clerk and treasurer. Ms Overton sent to Chief Widener:

"I have no idea who this guy [Frank] is that he [meaning me] is speaking of, do you?"

... to which Chief Widener responded:

This verification is incredibly easy—anyone can call the number and the person answering the phone can immediately check the personnel records. It took me about 30 seconds on the phone.

In a ComplaintsBoard thread <http://www.complaintsboard.com/complaints/fire-chief-chris-james-augusta-georgia-corruption-lying-about-good-firefighters-c673555.html>, an account suspected of being Frank posts:

“And in New Orleans; Security Officer & Police Officer- ARE CONSIDERED THE SAME JOB!! And no matter what law enforcement agency you are with- YOU WORK WITH THE NEW ORLEANS POLICE DEPARTMENT!!”

... in reference to the Augusta Chronicle news article of the previous day <http://chronicle.augusta.com/news/education/2013-06-05/protesters-call-copeland-elementary-principals-dismissal> where reporter **Tracey McManus** contacted the New Orleans police department and learned Frank had never been employed by them, and Frank later said he had been a security officer. So, in this post, the user (supposedly speaking on Frank’s behalf) is claiming you work for the New Orleans police department whether you are an actual police officer or security officer, so Frank wasn’t actually lying when he claimed he had been a police officer but later admitted it was a security officer.

It is worth noting that when I spoke with the New Orleans Police Department to verify Frank’s claim of being a former officer with them, I also asked if security officers or forces of any sort who were not themselves police officers are considered to be “the same job” as an officer (quoting the ComplaintsBoard post, and that security officers are not considered law enforcement officers or members of a law enforcement agency in New Orleans. To paraphrase, I was informed that any security personnel are the employees of private companies and are **not authorized** to enforce any laws, just their **company’s policies** and protect the security of those companies and their clients.

Also, the claim in this ComplaintsBoard post made by **User4987234** goes on to say that he in turn contacted the NOPD human resources to see if Tracey McManus called them, and this user claims their response was no. This claim is provably false. I’m not saying Frank didn’t necessarily call them, but my own experience with them shows there is no way for Frank to verify this. When I called, I was not required to give my name, nor was I required to fill out any paperwork, fill out a log, or make any other form of identification. I called the number, asked my question, and was told no “Beckles” had ever been employed by them. Also, I tested this account’s claim further by asking if Tracey McManus had called them asking any questions, and their response was (to paraphrase) that they do not keep any records regarding that, so there was no way of knowing.

User4987234 also claims in this post that Tracey McManus did not produce the name of the person she spoke with at the NOPD HR department. This is likely true, but not in the context **User4987234** is trying to present it. When I spoke to the NOPD HR department, no name was provided by the woman who picked up the phone – she merely announced the department I had contacted (which is fairly standard when dealing with an organization, considering you’re interested in the department and not the people working there.) I never thought to ask for the woman’s name, either. I had the information I needed, and that was that so far as I was concerned.

If anyone wants to verify this process for themselves, they are free to do what both Tracey McManus and myself did: call the NOPD HR department and see for yourself. Don’t take the word of **User4987234**, Frank, Tracey McManus, or myself on faith.

However, Joe Quesada, Marvel’s editor-in-chief in 2005, mentioned online wanting to bring the characters back but legal issues with IP holders, none of which are Frank Beckles (who claims to be an original cofounder and writer of Malibu, and that he is regaining rights to profit shares, etc.)

A search of every Malibu / Ultraverse series at <http://www.comics.org> revealed no one named “Beckles” attached to any of the comics in any capacity whatsoever. I also looked through my rather extensive collection of Malibu/Ultraverse comics (there are holes in the collection because I was paying for university at the time) and verified no one with the surname “Beckles” ever appears amongst any credits of the comics I personally own, be the credits in the copyright block or the in-panel credits.

Note this article from <http://malibucomics.blogspot.ca/2011/03/ultraverse-comics-anthology.html> and compare it to the Ultraverse’s Wikipedia entry on the Ultraverse. Beckles has taken the Wikipedia entry and edited himself into it. Copyscape indicates Frank’s version copies 76% of the Wikipedia original article:

In June 2005, when asked by Newsarama whether Marvel had any plans to revive the Ultraverse, Marvel editor-in-chief Joe Quesada replied that:

Let's just say that I wanted to bring these characters back in a very big way, but the way that the deal was initially structured, it's next to impossible to go back and publish these books.

There are rumors out there that it has to do with a certain percentage of sales that has to be doled out to the creative teams. While this is a logistical nightmare because of the way the initial deal was structured, it's not the reason why we have chosen not to go near these characters, there is a bigger one, but I really don't feel like it's my place to make that dirty laundry public.

Here is Beckles's follow up on <http://malibu.comocs.blogspot.ca> (and others):

In June 2005, Ultraverse editor-in-chief Dr. Franklyn V. Beckles, Jr., told an online interviewer that he will revive the Ultraverse Comics industry, and that the "initial structure" of Marvel's contracts with the Ultraverse creators, and partnership with DC Comics entitles them to share the profits made with these characters, making any revival "possible". Some creators have gone on to write for other titles with Dynamite Comics, explain that while the contracts do entitle them to a small percentage of profits, their characters are created as 'work-for-hire' and Marvel's ownership, allows them to write for new titles, including characters based on classic tv or cartoon shows, actors, musicians, and real life heroes.

You'll note the state of the legal issues regarding the Ultraverse between Joe Quesada's statements and those of Beckles don't line up at all. Also keep in mind that there is no listing that I could find anywhere regarding Frank's company, "Ultraverse Publishing Company," under which he claims to be preparing to relaunch the Ultraverse titles. No such business is registered, has a website, or phone number. The only references available regarding it are Frank's own web posts.

What's more, none of the names Frank Beckles uses appear in any of the major databases that tracks comic book professionals, such as <http://www.comics.org> or <http://www.comichron.com> or <http://www.comicvine.com>. This includes searching for his last name on its own. I'm certain it's only a matter of time before he says he did all his work under a pen name he somehow failed to mention anywhere on all the sites where he made claims about a history in comic books.

The editor-in-chief and associate publisher was Jim Salicrup.[1] Editors included Len Brown (co-creator of Topps' 1962 Mars Attacks cards), Howard Zimmerman, and Dwight Jon Zimmerman. The company's sales and promotions manager Charles S. Novinskie is listed as, additionally, a Topps Comics editor in his capsule biography at Non-Sport Update magazine.[4] The company's design director, Brian Boerner, is listed as Reprint Editor (along with Charles S. Novinskie) in the Xena trade paperbacks' credits.

Looking over Beckles' blogspot page, you'll note much of the rest of the text referring to Topps is also taken from these two other sources, and then broken up and heavily edited to insert himself. Here is the Wikipedia entry on the Mars Attacks Topps card set. It verifies the release was for 1962 http://en.wikipedia.org/wiki/Mars_Attacks and mentions an expansion set was released in 1994—my guess is this is the date Frank uses because it's what popped up when he was checking his falsified information.

Note that Frank makes himself the editor-in-chief and relegates Len Brown, the guy who created the original series and was its editor-in-chief, and filled the same role in the 1994 expansion pack, to "jr. editor." Oddly, when Topps released a 50th anniversary hardcover of all the 1962 and 1994 cards in a hardcover book, it was Len who wrote the foreword and no one with the surname "Beckles" appears in the credits (I've attached a scan of the credits page, which lists everyone involved with the project, so you can see for yourself.

And here's more proof: **I own the Mars Attacks 50th Anniversary Collection** <http://www.amazon.com/Mars-Attacks-The-Topps-Company/dp/1419704095> hardcover. It lists the credits for both the original 1962 set and 1994 release. There is **no** "Frank Beckles" or anything similar amongst any of the credits, with Len Brown being credited for the work Frank claims he did.

Sept 10, 2013: I called the station at **888-725-8033** and spoke with personnel. They never heard of Frank Beckles. When I described him using the photo he posted on the accompanying MySpace pages, they still had no clue who he was.

I think he's sort of skating the line of truth with this one because in some references he tries associating his self-appointed title of "TV Evangelist" with WBPI to imply he was a regular personality, but in other locations his phrasing suggests he's asked on the show "for inspiration" and as a guest.

I cannot verify if he has or has not been interviewed by the station or otherwise temporarily been put on air in a capacity that did not require he be employed there, but I've seen photos he's posted that could have been one of their show's sets where he was on as a guest.

Either way, they didn't recognize his name. The following is a rather extensive guest list of their Club 36 show, which he claims to be on, and his name doesn't appear on it.

All available photos were too small and too low of resolution to speak to their validity with absolute certainty, but one photo lists his degree as “**Master of Theology**” and another as “**Doctor of Philosophy in Theology**”, yet both list their dates of issue as “**The Twenty-Ninth Day of June A.D. 2002**,” meaning Frank obtained both his Masters and Doctorate on the same day.

It is possible to do this in programs where the Masters is earned “along the way” to the PhD, but it is not the most common method. I was unable to get information

I used the degree verification service employed by South Carolina State University and they responded with verification that Frank Beckles received a **Bachelor of Arts degree in History** that was awarded **May 9, 1999**. When I submitted the request, I was asked for a date around which they should look for the degree. I provided 2002, and yet the degree they provide is for 1999, and in history (which Frank doesn’t mention in any of the information I’ve seen him provide.) See **page 76** for a scan of the search results provided to me.

Note that the search of SCU records indicate this is the only degree Frank earned from them.

Keep in mind that if all the date ranges Frank provides regarding his various degrees are accurate, Frank was getting separate Masters and Doctorate degrees from two different schools simultaneously. Not only are they in different states (New Life Seminary is in NC), but they are 121 miles apart, as the crow flies (meaning the effective distance between them is much farther if one follows roads.) Putting the two addresses into Mapquest.com to get driving directions on the fastest road route, it is a little over a 140 mile drive of an estimated 2 hours, 23 minutes.

This time / distance is between the two schools, let alone drive time to and from Frank’s home at the time. I leave it to you to decide how likely it is Frank was simultaneously attending both degree programs at these schools.

If you click on the DatabaseFootball.com link that is supposed to point to his be his football stats, it actually leads to **Ian Beckles** a player born in Montreal, Canada, who was drafted in 1990 (not even within the range Frank gives above) to play for Tampa Bay, and was born in 1967 (5 years before Frank.) Ian Beckles also played a different position than Frank claims. Note that Ian Beckles is the **only** person with the surname “Beckles” to appear on this site.

Here are the team rosters for the Atlanta Falcons for 1996, 1997, and 1998. **None** have anyone with the name “Beckles” listed.

In the angelfire site, Frank claims:

“Beckles, who wore jersey no. 76, departed as a free agent after the 1998 season, inking a deal with Augusta. Beckles, however, did want to leave the Falcons, and blames then Falcons offensive line coach Chris Foerster for the split from the organization.”

According to the Atlanta Falcon’s official roster, in 1997, 76 was worn by **Antone Eugene Davis**, and no one had #76 in **1996** (probably why Frank chose it as his supposed number, not bothering to check in the years to come that he claimed to be on the team.) Also, **Chris Foerster** was the offensive line coach for Tampa Bay from 1996 to 2001. The Falcon’s offensive line coach in 1997 was **Art Shell**.

All details I found regarding Augusta’s arena football teams list the **Spartans** (who became the **Colts**), and the **Stallions**; the first two were not operational from 1999-2000, and the latter was from 2000-2002. There was a **Macon Knights** team for Macon Georgia, but they didn’t exist until 2001.

On many of his pages, Frank refers to himself as a “NFL star” or the like.

This ComplaintsBoard account Frank created, entitled “**Unsung NFL Hopeful**,” has a photo of Frank in his high school football uniform. This photo appears on several of his other sites. So, if he was a professional NFL player—especially as good as he claims elsewhere—why would he describe himself as both “unsung” and as an “NFL hopeful”? A “hopeful” is someone who aspires to something, not someone who has actually done it, as Frank claims elsewhere. Frank is contradicting his own claims.

If you hover over some of the pictures here, you'll see it proclaim the picture of Frnak to be something like "Vic Beckles a.k.a. 'BJ Kool' Rap City Star", which has to be the most ill conceived rapper name ever.

Firstly, a search of the station's radio personalities lists no Beckles, Djay Mofif, DJ Motif, Motif, etc. I also found no shows hosted by anyone with a name remotely like this using their searchable schedule. Secondly, keep in mind this is a Christian FM radio station located in Jamestown, TN. Not only do I doubt they are playing rap or hip-hop, but the station is also over 250 miles from Augusta, GA, where Frank lives. That's a pretty long commute, especially considering everything else Frank claims to have on his plate. It is especially unusual for someone who likes promoting themselves as much as Frank does not to have an Imdb account.

Here is the text from Frank's shutterfly site I ran through Copyscape:

Tracey McManus, The Augusta Chronicle Reporter

Accusation of being a liar, racist, "feminist", and being part of a conspiracy to discredit Frank

After writing a news article about Frank Beckles' issues with the Augusta board of education, during which she conducted due diligence regarding his claims to her of being a fire fighter and former police officer in New Orleans, she found he was no longer employed as the former and never as the latter, stating Frank later admitted he had been a security officer. She mentioned this in her article. Frank has taken issue with this, and is now posting far and wide across the Internet that Tracey McManus is a "racist", "feminist", and "liar" (amongst other things.) He has created many posts on various sites to spread this claim.

It should be noted that I have verified Tracey McManus' findings regarding Frank's claims about being a New Orleans police officer and fire fighter (see the Employment section for details of those finding.)

Among the accusations is that the staff "made them drive for miles to see her" (were they supposed to make a housecall?), claimed they said the miscarriage was the fault of Frank and his wife, they laughed at his wife, and that they told them "babies aren't important anyway." He follows this up with posts from some of his suspected alternate accounts.

Alexander Pope / Matt Gagston Identities

Frank has created a number of websites similar to his many Beckles sites, but has instead created them under the names “**Alexander Pope**” or “**Matt Gagston**.” These sites are constructed in a similar fashion to his Beckles sites, but at times Frank seems to be projecting his fantasy life on to these two imaginary people instead of himself, while at other times he uses these identities to hype himself. You will see that Frank often ties his own life together with the lives he has created for these two “people,” by saying he has (or will be) taking part in something with them, such as co-starring in the same movie.

It is possible that Frank actually knows two people with these names, but they certainly don't exist in the form Frank has devised.

I was led to these pages after researching the names when they appeared amongst the list of movies Frank claims to be working on.

Like Frank, “Alexander” is supposedly a movie star and football player, but I couldn’t track down any details of this person being either, which is odd considering he is supposedly an “**icon**” (according to this site), and is in the “TV hit series,” “**The Chronicles of Gagston & Pope**” (which doesn’t seem to exist – the only thing that comes up in a search for it are links back to this website and a LinkedIn page <http://www.linkedin.com/in/michaelquinton-pope> of Alex’s supposed son, Michael.

A seeming outlet of Frank’s misogynistic fantasies, the site claims Alex is married to pornographic actress, **Nina Mercedes** (a quick online search verifies Nina is, actually, married to **Raymond Balboa**), and that they have 20 kids (Nina actually only has one son.) The site claims Alex has over **105** kids from “**Beautiful Women ALL OVER THE WORLD!**” Elsewhere on the site it claims he has over **109** kids.

Later, it claims **Paula Maxine Patton** (a mainstream actress the site states was in pornography, which she was not), divorced her husband, **Robin Thicke**, to be with her “true soulmate,” Alexander Pope (whom she is supposedly having triplets with.) The site goes on to cater to Frank’s misogynistic fantasies by saying the following of Paula:

She enjoys becoming a “Babymaker”, more than a career woman & actress, she wants to continue to have multiple babies in the years to come!!! Doing what REAL Women should be committed to be- “A Home-maker/ Barefoot & Pregnant!”

Paula is, in reality, still married to Robin Thicke.

This site also claims Alexander was the star of the **Prince of Persia** film (obviously this fictitious person was not), that he starred (past tense) in an **Assassin’s Creed** movie (which does not exist), and that Matt was the star of the **Dark Knight Rises** (he supposedly played Bruce Wayne) and will be in a bunch of other Batman movies. According to this site, Matt is married to **Dakota Kelly** and they have **30 kids**.

My theory is he chose the name “Alexander” for this false identity because it seems to be the middle name of his son, Christian <http://www.linkedin.com/in/christianalexanderbeckles>

Supposedly Alexander Pope's son. The site proclaims Alexander Pope's real name is **Gabriel Shaddai Martinez**, and that Alex is a "**wealthy native American/Saudi prince**", and a

"former Marine Special Forces Commander (Delta Force)"

... I guess no one explained to Frank that Delta Force is an entirely **US Army unit – no Marines allowed**.

Among other things, this profile claims Alex and Matt Gagston were recruited into the **CIA**, and that Matt was on "**Seal Team Six**" and helped capture **Saddam Hussein**. (Note that Don Shipley, famed exposé of fake SEALs, explains that most fake SEALs, aside from using the improper spelling of "Seal," also say they are on Team Six because it is the most famous, and the only team most of the public is aware of what they do.)

According to this, Michael's mother is **Sade Adu** (yes, the singer), who married "the love of her life" (which must be a disappointment to Nina Mercedez and Paula Patton), and that she has **8 kids** with him (**20** altogether), and is pregnant with **twins**. In truth, Sade is currently unmarried and has **1 kid**.

This page also claims Alex Pope and Matt Gagston are involved with

"New Movies, Comics, Cartoons, Anime, and Documentaries Featuring These New Iconic Heroes THAT ARE C.I.A. AGENTS FIGHTING INJUSTICE, FEMINISM, RACISM, & EVIL!!!"

This again illustrates Frank's opinion of women by putting "feminism" in with racism, evil, etc.

This identity also claims to be married to **Jada Fire**. This lists her as a "model", but she is actually a retired pornographic actress (seeing a pattern yet?) Aside from the fact that all the biographic information I could find on her says Jada was, and is, unmarried, but this article leaves out that her real name is Tenisha Roberta Myles. Despite the site's claim that Jada and Michael have **9 children**, she has only **1 kid**, a daughter.

A news feed article. If you search on the page for “**Aiken private school must find new site**,” you will see it details Frank announcing the shutdown of the Aiken Academy.

An article about how some newly hired fire fighters were being laid off from the **Augusta Fire Department**. Frank is mentioned as a **new hire** who is to be let go, and alleges doing so was “**unfair treatment**.” Him being let go is important because he (and suspected alternate identity accounts of his) elsewhere claim he worked at the fire department afterwards.

Frank speaks about keeping **Chris Green** home from school, and identifies himself as **Reverend Frank Green** who works at the **Augusta Christian Centre**. The news describes him as “**a mentor for kids from all over the area**.”

This story is the reason Frank calls **Tracey McManus** a liar. Her due diligence research into his claims of being a New Orleans police officer proved this not to be true (my own research similarly revealed this claim to be false.) Beckles even admitted he had been a security officer, not a police officer (he also lists a security job amongst his previous employment on some of his LinkedIn pages.) He also claimed to be a fire fighter in Augusta, but this was also proven to be false by contacting the **Fire Chief Chris James**.

The next day, this resulted in one of the ComplaintsBoard accounts suspected of being Frank posting a thread accusing Chris James of being a liar, and of corruption (Frank says he was employed with the Augusta Fire Department the entire time Chris James says he was not.) <http://www.complaintsboard.com/complaints/fire-chief-chris-james-augusta-georgia-corruption-lying-about-good-firefighters-c673555.html>

Frank meets with the press prior to the meeting with the superintendent, and identifies himself as Dr Frank Beckles.

Frank leads a group of “supporters” consisting of himself, his wife and kids, and what seems to be maybe four or five other adults in an otherwise empty room to hand over a petition of over 200 signees for **Kimberley Davis’** dismissal as principal at the school where Frank’s kid goes. Frank and friends walked out. Frank signed in to meet with **Principal Davis** using the name “**Frank Green**” and claimed to have spoken with her about the bullying incident that led to him calling for her dismissal, but she states she had no previous conversations with him.

This is an opinion piece about the superintendent Frank rails against after the former refused to acknowledge Frank’s petition to have **Principal Davis** removed. After this article appeared, it’s author, **Tracey E Williams**, became a new subject of Frank’s ire and accusations.

There are MANY user accounts on ComplaintsBoard that start up threads proclaiming Frank to be a hero, and a victim of a seemingly unending assault from racists (or racist feminists), liars, and people who just seem out to get Frank for no reason. Some of these users start their own threads while others jump in to basically say (to paraphrase and summarize) “yeah, I heard this too!” or “I’ve noted the same thing! Hurray for Frank!”)

You’ll note the posts are not exactly official, and claims that the **police**, Attorney General, and FBI are all monitoring ComplaintsBoard.com and have supposedly stated that the “**case is closed**” and no more comments are allowed in the thread. I know ... **TOTALLY** realistic, right?

What’s New?

The latest development (as of **Oct 11/13**) in this is Frank’s alternate identities claiming Tracey McManus has been fired over her “lies” regarding him <http://www.complaintsboard.com/complaints/tracey-mcmanus-augusta-chronicle-slanders-more-ministers-evil-witch-amp-her-reporter-friends-attacking-people-online-c681741.html?page=2>. However, you can visit her profile and see that it is still there <http://chronicle.augusta.com/users/tracey-mcmanus> or see that she has been posting articles to the site beyond Oct. 11 <http://chronicle.augusta.com/authors/tracey-mcmanus>.

None of this is definitive proof, of course, but look at the evidence and judge for yourself.

Recognizing Frank’s Grammar Style

Anyone spending any time looking over what these users post under random, anonymous names and names that claim to be real people supposedly spilling their guts to “**admit**” they have been racist or otherwise maligned Frank, is that they all seem to use the same long-winded, rambling, sometimes incoherent syntax and writing style. They even share some of the same poor grammar mistakes. What an odd coincidence, no?

For instance, on his own webpages wherein Frank identifies himself as the person writing the site’s content, he likes to refer to himself as the “**renown**” something-or-other. For example, on <http://www.linkedin.com/in/frankbeckles> he refers to himself as both “a **renown Public & Private School Teacher**” and “**an renown Athlete from 1991-2002**”, and on <http://www.linkedin.com/in/captainbeckles> he refers to himself both as “**Renown Church Pastor On APSense Ordained & Renown Minister: Rev. Dr. Franklyn V. Beckles, Jr.**” (using the word twice) and “**a renown Public & Private School Teacher**” (stating this twice on the page.)

The thing that stands out about this, other than the sheer humility, is that Frank doesn’t know he is using the word improperly. “**Renown**” is the word as a noun. You can obtain renown, you can earn renown, but something cannot be renown. The word Frank is looking for – the adjective version – is “**renowned**.” Frank doesn’t know this so he is constantly using the word improperly. It’s a common trait of his writing (and that of his proxy identities.)

So, go to ComplaintsBoard and search for “**renown**” and also go to Google and search for “**reown Beckles**”.

What you’ll find is many of the user accounts there suspected of being Frank erroneously using “renown” as an adjective to describe Frank Beckles, just as Frank does. Add that to the many other commonalities these accounts share with the writing Frank does under his own name, and you can see how strong the argument is that all of these people confessing to have done Frank wrong or who are supporting him are actually Frank posting under false accounts.

Once you spend some time looking over Frank’s page, it’s very hard not to immediately spot his particular choice of words and rambling style elsewhere.

If so, he is lying.

ComplaintsBoard.com User Accounts (Identified and Suspected)

Many of the following accounts are suspected of being owned by Frank because they a) either identify themselves as him or b) jump in to defend him out of the blue, with no prior posting history or previous posts about rampant racism in Frank's area. Regardless, they post in Frank's online writing style and have an odd habit of trumpeting his supposed accomplishments, including when entirely out of context, and make unusual use of the various nicknames he has given himself. Many also copy and paste the same posts from each other (some of which are taken directly from Frank's many websites.) It is also common for these users to say something about Frank—either to say good things out of the blue, or to defend him—and then disappear.

Some of these identities are real people who Frank is suspected of impersonating on ComplaintsBoard in order to give support to his claims. Yet, even those with real names immediately jump to calling Tracey McManus as a liar, a racist, etc., while calling Frank a "true hero" and "civil rights hero" right away, without establishing any credibility or pausing to take in the conversation (almost as though they are all the same person sharing the same, pre-existing train of thought rather than separate people just joining the conversation for the first time ...)

Some of these accounts actually use photos that Frank posts on his other sites, putting them in as their user profile picture or dropping them into threads (often without any connection to what is actually being said.)

Note that the claims made in this thread created by a suspected alternate account for Frank claims Frank was working as a fire fighter for two years after Frank was dismissed, calling Fire Chief Chris James a liar for saying Frank no longer worked there in a news story posted by the Augusta Chronicle. Frank apparently forgot a previous statement he gave the Augusta Chronicle in 2010 declared he, a new hire, found his termination was the result of “unfair treatment.” Yes, this means Frank’s own previous interview with the news two years earlier proves he had not been working for the Augusta Fire Department for the two years following, as this ComplaintsBoard account claims.

You’ll notice Frank has added a great deal about how the school will “harass black male students, and kick them off campus for no reason” and the like, adjusting the article’s focus and interjecting Frank’s own agenda. He also takes the part where Dr. Watkins mentions “lineman Anton Gunn” and inserts himself by changing the line to “linemen Anton Gunn & Vic “The Ice-man” Beckles.”

Posts in Frank’s style, brings up same issues, and joins in threads started by other user accounts about Frank to interject “facts” about Frank, like him having been a DC editor. The post proclaiming himself “the Falcon” seems to be trying to establish this profile with some comic book credit.







under the leadership of owners and creators; Matt Choinaire, Matt Gagston, Alexander Pope, Rev. Dr. Frank Victor "The Iceman" Beckles, and Dwayne McDuffie. Following the success of Image (a studio of comics' top artists each publishing their own book contained in its own mini-universe) and Valiant Comics (a cohesive universe shared by all the Valiant characters - the model the Ultraverse line aimed to imitate), a number of new universes were launched including Milestone from DC and Comics Greatest World from Dark Horse. While it was not as successful as Image or Valiant Comics, Ultraverse was successful relative to the other universes. They boasted improved production values over traditional comics (especially digital coloring and higher-quality paper), and a roster of respected and/or talented new writers and artists. Following the Valiant Comics formula closely, Ultraverse emphasized tight continuity between the various series in their line, Malibu made extensive use of crossovers, in which a story that began in one series would be continued in the next-shipping issue of another series. Various promotions for special editions or limited-print stories also encouraged readers to sample issues of the entire line. Many fans loved the scope of storytelling this approach allowed; others complained of the effort and cost of buying the issues necessary to keep track of it all. Regardless, the Ultraverse line came to dominate Malibu's catalog.

As sales declined industry-wide **in the mid-1990s, Malibu cancelled lower-selling series. The company was purchased by Marvel Comics in 1994** (with Dr. Beckles as part-owner). Reportedly **Marvel made the purchase to acquire Malibu's then-groundbreaking in-house coloring studio, and/or its catalog of movie-licensable properties.** Others believe that Marvel simply wanted to put a significant competitor out of business. Marvel did not cancel **the entire Ultraverse line, but (during the controversial Black September event) Dr. Beckles (now Editor-in-Chief in 1999) re-launched a handful of the more popular titles as well as a number of crossovers with Marvel characters. The "volume 2" series (in 2000) each started with "# ∞ (infinity)" issues and were cancelled a short time later. Within the Marvel & DC Comics multiverse, the Malibu Universe is designated as Earth-93060.**

ULTRAVERSE REVIVAL (2005-PRESENT)


In June 2005, Ultraverse editor-in-chief Dr. Franklyn V. Beckles, Jr., told an online interviewer that he will revive the Ultraverse Comics industry, and that the "initial structure" of Marvel's contracts with the Ultraverse creators, and partnership with

Among Topps Comics' notable artists besides the aforementioned were [Charles Adlard](#), [Rich Buckler](#), [Dick Giordano](#), Miriam Kim, Rick Magyar, [Esteban Maroto](#), [Mike Mignola](#), [P. Craig Russell](#), Alex Saviuk, [Anthony Williams](#), and [Thomas Yeates](#). Some covers and frontispieces were drawn or painted by [Tim Bradstreet](#), [Kelley Jones](#), [Michael William Kaluta](#), and [Jim Steranko](#).

The company's sales and promotions manager Charles S. Novinskie is listed as, additionally, a Topps Comics editor in his mini-bio at

Non-Sport Update magazine.^[1]

The company's design director Brian Boerner is listed as Reprint Editor (along with Charles S. Novinskie) in the Xena trade paperbacks' credits.

The Kirbyverse

The "Kirbyverse" comics, launched simultaneously with April 1993 cover-dates, stemmed from character designs and story concepts that the prolific Kirby, at this very late point in his life, had in his files of unrealized projects and preliminary sketches (some for [Pacific Comics](#), which went defunct in the 1980s). Topps licensed them for an eight-title, interrelated mythos based around what became *Jack Kirby's Secret City Saga*. That flagship title was written by former [Marvel Comics](#) editor-in-chief [Roy Thomas](#), with an issue #0 prequel drawn by artist [Walt Simonson](#) and the remainder of the series by [Spider-Man](#) co-creator [Steve Ditko](#).

Kirby himself wrote and drew eight pages (which may have been drawn in the 1970s^[2]) of the *Satan's Six* premiere, interlaced with story pages by writer [Tony Isabella](#), penciler [John Cleary](#) and inker Armando Gil. As well, the covers of the *Bombast*, *Captain Glory*, and *NightGlider*^[3] one-shots noted below were built around preexisting Kirby character-design art.



Career

Campbell's first starring role was Daisy in the Canadian youth TV series *Catwalk*, which she held from 1992 to 1994. She rose to fame outside Canada after being cast as Julia Salinger in the drama series *Party of Five*, in which she performed from 1994 to 2000.

Campbell's first widely released film was 1996's *The Craft*. She then had a starring role in the *Scream* horror film trilogy. Roger Ebert, in his review of *Scream 3*, wrote of Campbell, "The camera loves her. She could become a really big star and then giggle at clips from this film at her AFI tribute."

Campbell also appeared in *Wild Things* and *Three to Tango*. In 1998, she was on *People's* "50 Most Beautiful People" list.

However, despite this diligent search, we were unable to locate documents indicating that Franklyn Beckles aka Frank Beckles aka Frank Victor Beckles ever qualified as a U.S. Navy SEAL or participated in U.S. Navy SEAL training.

If you believe an adequate search for responsive records was not accomplished, you may consider this an adverse determination of your request that may be appealed in writing to:



I greatly appreciate your interest in upholding the honor of the US Navy SEAL Teams, and your search for the TRUTH.
